WHEREAS, Show Cause Notice Section 17 is issued to the following Recognised Teacher Education Institution (Sl. No. 01 to 1469) of the Minutes of 325th (Virtual) Meeting of the NRC, NCTE held on 08th to 09th January, 2021, Section 17 of the NCTE Act, 1993 for submission of their reply/documents on the following grounds:-

1. In compliance the decision of 318th meeting, the Committee observed that no documents in compliance of LOI are available in the file of the institution.

Hence, Show Cause Notice under Section 17 of the NCTE Act, 1993 be issued to the institution on following grounds.

The institution is required to submit to NRC:

- 1. Original/Photocopy of the documents duly certified by the management of the institution submitted to NRC in compliance of LOI.
 - a) Copies of Fixed Deposit Receipt of Endowment Fund & Reserve Fund in the joint account of RD, NRC, NCTE & Society authority alongwith Bank form "A" verified by the Manager of the Bank. submitted to NRC in compliance of LOI
 - b) Downloaded copies of the website of the institution with hyperlink of the same as per provisions of 7(14) of the NCTE Regulations, 2014. Submitted to NRC in compliance of LOI,
 - c) List of faculty duly approved by the affiliating body/university alongwith related documents. Submitted to NRC in compliance of LOI.
- 2. The institution is required to submit proof/evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- Proof regarding submission of compliance of LOI in NRC.

While scrutinizing the file of NRCAPP-5449 as per instruction of Hon, able CP, NRC, the office of NRC observed that there are number of institutions granted recognition for different courses in session 2015-2016 without fulfilling the requirements of LOI/other mandatory obligations required to be completed as per Regulations, 2014, by the following orders of NRC.
